The Chair referred to his previously-distributed report on the recently-concluded Mid-Term Election.

The Vice-Chair reported on his progress as IT Chair. Stripe account has been set up integrated into the Web site. LPID.org is now the primary site, and relevant e-mail address have been created. Amazon web services account has been set up (free for <62,000 e-mails per month).

The Treasurer reported on his progress in integrating our operations with LNC particulars (switching from Nation Builder to Raiser's Edge). He noted that \$245 was donated after the First Interstate account was closed, but has not been received.

We need to prepare a standardized contribution form, integrated with the Web site, because of state limitations and requirements on contributions (\$50 limit, for example).
